AN ORDINANCE AMENDING ORDINANCE NO. ⁰⁹³~~088~~-139 ENTITLED: "AN ORDINANCE CREATING A PLANNING AND ZONING COMMISSION FOR THE VILLAGE OF VINTON, TEXAS.

BE IT ORDAINED BY THE VILLAGE COUNCIL FOR THE VILLAGE OF VINTON, TEXAS, THAT:

I.

ORDINANCE NO. 088-139, Section II, entitled MEMBERS, TERMS is hereby amended in part and shall now read:

II.

MEMBERS, ALTERNATES, TERMS

Members

The Planning and Zoning Commission shall consist of seven (7) members who shall serve for terms of two (2) years. Two (2) alternate members shall also be appointed to serve for terms of two (2) years. No members of the Village Council may serve on the Planning and Zoning Commission.

The terms of appointment and initial terms of the members of the Planning and Zoning Commission shall be as follows:

The members of the Planning and Zoning Commission shall be appointed by the Mayor and Village Representatives Places 1,2,3,4 and 5.

It is the intent of this Ordinance to further provide for staggered terms of the membership. Therefore, during the initial terms of the members, those members appointed as Mayor's appointment A and by Village Representative Places 1, 3, and 5, shall serve for a period of two (2) years. Those members appointed as Mayor's appointment B and by Village Representative Places 2 and 4 shall serve for a term of one (1) year.

Appointed members shall not be eligible to appointment or transfer to fill another Planning Commission place until the term of their originally appointed place expires.

At the end of each initial term, all future members shall be appointed for two (2) year terms.

Alternates

The alternates to the Planning and Zoning Commission shall be appointed by the Mayor and shall serve in the absence of regular members when requested.

It is the intent of this Ordinance to further provide for staggered terms of the alternates. Therefore, the alternates shall be appointed to places A and B. During the initial term of the alternates, the alternate appointed to Place A shall serve for a term of two (2) years. The alternate appointed to Place B shall serve for a term of one (1) year.

At the end of each initial term all future alternates shall be appointed for two(2) year terms.

II.

All other language under Section II not amended by the above shall remain in full force.

III.

Ordinance No. 088-139, Section VI, shall be amended and shall now have added the following:

"If the Planning and Zoning Commission is unable to make a final recommendation to the Village Council within forty-five (45) days from the date that the item is first placed upon the Commission's agenda then the Village Council is authorized to call that item from the Planning and Zoning Commission and take action on same without the Commission's recommendation.

IV.

All other provisions contained in Ordinance No. 088-139 and not amended by this Ordinance shall remain in full force.

V.

That this Ordinance was duly enacted with all requisites and formalities incident thereto the enactment of ordinances, and such is evidenced by the below signatures.


