A RESOLUTION OF THE VILLAGE OF VINTON, TEXAS AMENDING CONSOLIDATED MASTER FEE SCHEDULE

WHEREAS, the Village Council of the Village of Vinton, Texas adopted a consolidated Master Fee Schedule for municipal inspection and code compliance services by Resolution No. 2015-11-2-2 to facilitate public access, Council review and future update. The consolidated Master Fee Schedule has been amended twice by Resolution Nos. 2018-07-17-1 and 2019-02-19-to reflect changes in services and applicable fees. The Council has since approved additional fees and fee changes such that it is necessary to further amend the consolidated Master Fee Schedule by adoption of this Resolution to reflect these changes;

WHEREAS, the Village Council intends that the cost to the Village of providing municipal inspection and code compliance services be borne proportionately by all persons receiving the services;

WHEREAS, the attached fee schedule has been determined based upon the cost to the Village to review and process applications, conduct inspections and monitor compliance with applicable laws and regulations for the purpose of preserving and promoting the public health, safety and welfare and to provide other identified municipal services as required by law.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF VINTON, TEXAS as follows:


1. That the attached amended consolidated Master Fee Schedule be, and the same is hereby, adopted by the Village of Vinton, Texas.
2. All prior fees adopted by the Village Council in conflict herewith are hereby repealed and replaced with the fees set forth in the attached consolidated Master Fee Schedule.
3. This Resolution shall take effect on the date of its passage, and it is accordingly so resolved.

Recurring fee is payable in advance upon approval of the permit. Initial amount shall be prorated, based upon an annual due date of January 1 of each year, thereafter, all payments of recurring fees are due to the City by January 1 for the following calendar year.
Recurring Annual Rental Rate - <i>Collocation of Network Nodes on Municipally-Owned Service Poles</i>	An annual rate of \$20 per municipality owned service pole. Recurring fee is payable of the permit. Initial amounts shall be pro-rated, based upon an annual due date of January 1 of each year; thereafter, all payments of the recurring fees are due to the City by January 1 for the following calendar year.
