

ORDINANCE NO. 096-1219

AN ORDINANCE ADOPTING A BUDGET FOR THE
FISCAL YEAR COMMENCING JANUARY 1, 1996,
AND ENDING ON DECEMBER 31, 1996, FOR THE
VILLAGE OF VINTON, TEXAS

WHEREAS, the proposed Village Budget prepared and submitted by the Mayor was received on the 7th day of November, 1995, which budget was placed on file at the office of the Village Clerk for public inspection prior to said date; and

WHEREAS, proper notice was provided by publication of the proposed Budget and consideration of adopting said Budget by ordinance was only after public hearing held on December 5, 1995, at the Vinton Village Hall which hearing was continued from day to day and from time to time until the 19th day of December, 1995, and was then closed, and

WHEREAS, at said hearing, all desiring to contest the said proposed Village Budget for the fiscal year January 1, 1996, to December 31, 1996, correct the same, or in any manner be heard concerning the benefits thereof, or in any other manner, were heard, and errors and all matters of error or mistake or inequalities or other matters requiring rectification which were called to the attention of Council were rectified and corrected; now therefore,

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF VINTON, TEXAS, THAT:

SECTION I

That the action of the Village Council closing the hearing and overruling the protests at the public hearings, in these proceedings, is hereby ratified and confirmed by this Ordinance. That the Village Council, from the evidence finds that the adoption of the proposed Village Budget, which was prepared by the Vinton Village Council, is in the best interest of the citizens of Vinton, Texas, and will further the purposes and goals of the citizens of the Village, and will enable the government of the Village to carry out its necessary functions.

SECTION II

The Village Budget, which is attached to this Ordinance, is adopted in full under which the Village of Vinton, Texas, will operate during the fiscal year of January 1, 1996, to December 31, 1996.

SECTION III

The Village Budget shall be on file with the Village Secretary for public inspection throughout the fiscal year of January 1, 1996, to December 31, 1996, and a true and correct copy of same will be delivered in hand, at the Village Clerk's Office upon the request of any citizen of the Village of Vinton, Texas.

SECTION IV

That this Ordinance has been duly enacted with all the requisites and formalities incident thereto the enactment or ordinances, and such is evidenced by the below signatures.


